1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. 2. Generic

Red mud filtration unit

Mud filtration unit is used to filter bauxite residue slurry obtained during Bayer process of alumina production. This unit will help to study the rate of mud filtration as well as the solid content in the filter cake sample. Bauxite residue slurry is filtered through a filter cloth fitted in mud filtration unit. Cake is formed between the plates of the unit and filtrate percolate out. The weight of the cake, time of filtration and filtrate volume are measured. This unit is helpful during bauxite processability studies to understand the mud filtration behavior.

Lab scale mud filtration unit

- The unit should be essentially consisting of slurry tank 5 litres made up of SS 316 to withstand 15 Kg/cm² pressure.
- The filter plate made up of SS 316 having radial and annular groves to hold the residue after filtration should be placed between the plate and filter cloth.
- Ceramic Band type heaters having 2.5 kW capacity should be provided with ceramic wool insulation and aluminium cladding.
- Stirring unit having ¼ HP geared motor and 240 VAC to be top mounted with suitable mechanical seal and all essential accessories.
- Washing tank having 5 litres capacity should be made up of SS 316 to withstand the pressure up to 15 Kg/cm².
- Suitable pipeline and connections including ball valves made up of SS 316 to be placed in between slurry tank, water tank and filter assembly.
- All fittings should be suitable to withstand high pressure up to 15 Kg/cm².
- Complete unit to be mounted on strong angle Iron stand and should be powder coated.
- The thermocouple (PT 100 Sensor) inserted in the slurry tank should be connected to the temperature controller (up to 110°C maximum).
